**1. ACCESSORIAL CHARGE APPROVAL**

- a. All accessorial charges requiring client approval will be deemed accepted and billable if no response is received within 48 hours of submission.

**2. ADDITIONAL LABOUR & LUMPER SERVICES**

- a. Loading / Unloading – Minimum 4 hours:
- I. Weekdays **\$45.25/hour**
  - II. Saturdays **\$66.50/hour**
  - III. Sundays & holidays **\$95.75/hour**
- b. Shrink wrap a pallet **\$7.00/pallet**
- c. Shipment label or packaging correction **\$5.75/carton**
- d. Hand Bomb Service LTL **\$3.00/ CWT – Minimum \$30.00**

**3. ADDITIONAL EQUIPMENT & SERVICES**

- b. Rental of protective blankets as follows:
- I. 1 to 2 days - **\$10.50** per blanket, per day. Minimum charge of **\$32.25**.
  - II. 3 days or more - **\$7.00** per blanket, per day. Minimum charge of **\$32.25**.
- c. Additional Services & Equipment include: Cross dock & Straps.  
REMCO can provide rolling racks for purchase or rental. Call for a quote.

**4. AFTER HOURS AND WEEKEND DELIVERIES**

- a. Normal Business Hours: **6:00 AM to 6:00 PM**. Any pickup or delivery request outside of these hours will incur additional after hours charges:
- I. **\$204.50** within metro areas – beyond metro must call for quote
  - II. **\$379.75** minimum weekends and holidays
- b. These surcharges will be in addition to the regular freight charges that are applicable to the shipment.

**5. ATTEMPTED / CANCELLED PICK-UPS**

**Attempted or Cancelled Pick-Up Charges will apply for:**

- a. Shipments cancelled within 2 hours of ready time with billed weight of less than 10,000 lbs. **\$46.75**
- b. Shipments with billed weight of more than 10,000 lbs. **\$117.00**

Charges applied to GTA & GMA for an attempt to pick up freight and one of the following occurs:

- I. Shipper changes pick-up time after truck has been dispatched.
- II. No answer at shipper's place of business.
- III. Shipper requests that the pickup be done at another address within the terminal service area.
- IV. Access to loading area at time of pickup was restricted or unavailable.
- V. Does not apply to dedicated moves.

**6. CALL AHEAD**

- a. Call ahead - **\$26.50**

**7. CARTON SORTATION**

- a. Carton shipments: **\$2.00** per carton with a minimum charge of **\$52.50** per shipment.

**8. CONGESTION / PEAK SEASON SURCHARGE**

At the sole discretion of REMCO, when deemed necessary and upon prior notification, a congestion surcharge of **\$1.50 / cwt minimum \$26.50, maximum \$159.50** may be applied to shipments in situations where REMCO's ability to perform services is impeded by temporary factors such as construction or road closures etc.

**9. CUBE (DENSITY)**

All rates are subject to **10** pounds per cubic foot (pcf) unless otherwise specified. Cubic weight calculation = Length (in) x Width (in) x Height (in) ÷ **1728 x 10**. If this amount is greater than the actual weight of the shipment, then the dimensional weight will be applied for calculating the freight charges.

If the bill of lading states "do not stack" or it is **impractical** to load other freight on top of the shipment, the height of **8 ft. (96")** will apply.

**Impractical:**

- a. More than **60"** in height.
- b. Any item marked "Do not stack" or similar wording.
- c. Skids or any items with a length and/or width 50 inches or greater.
- d. Any item that is identified as "**FRAGILE**".
- e. Items not evenly piled at the top of the pallet which will prevent stacking.
- f. Pallets with electronic products, such as TVs.
- g. Freight and packaging not strong enough to hold up to **400 lbs.** on top.
- h. Freight packed in plastic containers that are not stackable totes or bins.

**Packaging Notes:**

- a. Inadequately packed shipment and/or personal items will be shipped at "**Owners Risk**".
- b. If the weight of the shipment is not indicated, at the sole discretion of the carrier, a minimum weight of **40 lbs.** per carton will be used as an assumed weight. For pallets, a minimum weight of **800 lbs.** per pallet will be used as an assumed weight up to and including **60"** in height.
- c. **A quote must be obtained from [spotquotes@remco.ca](mailto:spotquotes@remco.ca) for shipments including items longer than 10 feet (120 inches), prior to shipping.**
- d. REMCO reserves the right to refuse any pick up of shipment(s) deemed insufficiently packaged to withstand the rigors of transport.

**Linear Foot Rule**

1. When a shipment occupies more than 10 feet or 5 skid spaces (see item **Impractical** for more definition) of trailer space the billable weight will be calculated at 1000 lbs. per linear foot.
2. Shipments moving to and from the province of Newfoundland / Labrador will be cubed at 15 pcf up to 10 linear feet of trailer space. Shipments in excess of 10 linear feet of trailer space will be subject to a cube restriction of 1,000 lbs. per linear foot.

**10. DANGEROUS GOODS**

- a. All Type Transport & REMCO Forwarding Ltd. do not handle any type of product that is deemed as "Hazardous Material" or "Dangerous Goods", (HAZMAT), as described in the WHMIS (Workplace Hazardous Material Information Systems).

**11. DECLARED VALUE: Ontario / Quebec / Eastern - Western Canada**

- a. For "No Declared Value" shipments, REMCO's maximum liability is **\$2.00/lb.** based on the actual weight of the goods lost or damaged, or **\$10.00** per hanging garment.
- b. Shipments with an expressed "Declared Value" will be charged at **3.00%** of the amount declared subject to a minimum of **\$10.00** per shipment.

**12. DOCUMENTS:**

- a. Proof of Delivery
- b. PODs are obtainable on **[www.remco.ca](http://www.remco.ca)** free of charge.

- c. A charge per document will be levied for all requested PODs, if available on [www.remco.ca](http://www.remco.ca).
  - d. Requests of PODs for shipments that are in excess of 60 days will be subject to a **\$29.25** charge per document.
  - e. Bill of Lading copies
  - f. Manual BOL creation/updating fee - **\$26.50**
  - g. Paper Invoice
- \$29.25 per document plus mailing costs:** This charge will apply when a copy of the document is requested and an electronic copy of the document is available through various means:
- I. Website
  - II. EDI

**13. DUNNAGE REMOVAL – DISPOSAL OF GOODS**

- a. Dunnage removal - **\$26.50** per skid
- b. Disposal of goods - **\$26.50** per shipment

**14. FREIGHT CLAIMS**

- a. Claims must be submitted in writing within **60** days of the shipment delivery date. Any claim submitted after **60** days will be denied.
- b. Payment deductions are not to be made under any circumstances.
- c. Freight claims will not be addressed until all transport charges are paid in full.
- d. At the sole discretion of REMCO, and due to weather, traffic or any act of God, REMCO may elect to temporarily cease operations.
- e. **Exclusion of Consequential Damages or Consignee Fines:** Notwithstanding any term or condition of the customer's Bill of Lading, if any, or any other provision to the contrary, **in no event shall REMCO be liable to customer, owner, consignor, consignee or any third party interested in the goods for any special, indirect, incidental or consequential losses or damages** including, but not limited to, loss of profits, downtime costs, fines assessed to the shipper by the consignee, delay costs and costs of substitute equipment arising out of or relating in any way to the non-delivery, miss-delivery, delay in delivery or late delivery of the goods or the loss, damage or destruction of the goods, howsoever caused, including, without limitation, the negligence, gross negligence or the fundamental breach of this contract by REMCO, its servants or agents, whether or not REMCO had knowledge that such losses or damages may be incurred.

**15. FUEL SURCHARGE**

All shipments are subject to fuel surcharge as updated weekly & available at [www.remco.ca/resources](http://www.remco.ca/resources).

Fuel Surcharge for shipments will apply as follows:

- a. LTL Billable weight up to 9,999 LBS
- b. TL Billable weight 10,000 LBS & greater, or 6 skids and over

**16. GARMENT BAGS AND GOH FREIGHT**

- a. Cloth garment bags (sample bags) exceeding the normal size set bag, will be charged two times the applicable rate.
- b. Each set of hanging garments must be covered with a poly-overwrap bag of no less than **1.5mm** thickness.
- c. REMCO will not be liable for loss or damage to garments if a poly-overwrap bag of lesser specifications is used.
- d. Overwrap bags can be purchased through All Type / REMCO.
- e. Individual sets must not exceed **50 lbs. (23kgs), 72" (1.83m)** in length, and should not exceed **8"** in width.
- f. Oversize sets will be pro-rated based on the width in excess of a standard set size and charged accordingly. The minimum charge for an oversize set is **1.5** times the applicable set rate.
- g. REMCO will not be liable for shortage if the number of garments within a set is not indicated for each set.
- h. REMCO will not be liable for damages resulting from oversized sets.
- i. REMCO will not be liable for any loss or damage to garments due to inadequate packaging. Please ensure that garments are hung on strong hangers and that the overwrap bags are securely sealed around the neck of the hangers.
- j. REMCO will not be responsible for any loss of market or any consequential damages.

**17. GUARANTEED DELIVERY SERVICE**

- a. All REMCO Services can be “**Guaranteed**” where it has been specifically requested by the customer in writing.
- b. Charges for “**Guaranteed**” will be a **30%** premium on net freight charges, based on the concurrent pricing for the customer, subject to a **\$58.50** minimum surcharge.
- c. This premium charge will be refunded if the shipment is not completed at the time of the day requested.

**18. HOURLY SURCHARGE**

- a. Hourly work done by either straight truck or tractor trailer: **\$111.00 per hour** billable in 15 minute increments.

**19. MANUAL PAYMENT METHOD**

- a. Payment method via cheque: Processing fee of **\$26.50**

**20. PROTECTIVE SERVICES**

Applies to perishables or to goods that may deteriorate by elevated temperatures or that may require **controlled** elevated temperatures

**21. RATES, BILLING & PAYMENT TERMS**

- a. All rates are subject to change and / or cancellation with a thirty days notice.
- b. All invoice terms are net **7** days. An administrative charge of **1.5%** per month (**18%** per year) will be charged on all overdue accounts.
- c. Any issues requiring adjustments to an invoice must be submitted in writing to REMCO at [arqueries@remco.ca](mailto:arqueries@remco.ca) within **30** days from the date of the invoice. No adjustments or credits will be applied after **60** days.
- d. For any adjustment to invoices with no fault to REMCO an administration fee of **\$29.25** will be charged.
- e. Except as otherwise indicated, rates include one pick-up from one shipper, and one delivery to one consignee. Shipments with bills of lading consigned to the same location will be rated individually. No consolidations will be offered.
- f. Requests for rate verification will be charged **\$17.50** per occurrence, when customer has existing rates.
- g. All spot quotes are estimates and are based on information provided at time of the request. The final price will be calculated based on actual weight and size of shipments as verified and confirmed upon arrival at REMCO’s dock. If an adjustment is required due to the Spot Quote number not being referenced on the shipper’s bill of lading then an Administrative fee of **\$29.25** will be assessed to research and perform the adjustment.

**22. RE-DELIVERY CHARGES**

Re-delivery surcharges will be applied on all refused shipments, on both the refusal and the redelivery portions (local charges only). Secondary delivery charges are as follows:

- a. **\$8.25** per 100 pounds with a minimum charge of **\$79.75** and a maximum of **\$175.25** per shipment.
- b. Charges are calculated based on the billable weight of the shipment.
- c. The above charges will apply to shipments moving within REMCO’s direct service points.

**23. REDIRECT AND/OR RE-CONSIGNMENT CHARGES**

- a. A minimum charge of **\$81.75** plus applicable line-haul charges from the original destination to the new destination will apply.

**24. RENDEZ-VOUS / APPOINTMENT / WINDOW DELIVERIES / DC Delivery Appointment**

NOTE: Appointments outside of standard business hours will also be subject to appropriate after-hours or weekend charges

- a. **RENDEZ-VOUS - APPOINTMENT: less than 2 hours will deem as Rendezvous**

- b. **WINDOW DELIVERIES – minimum 2 hours**

**C. DISTRIBUTION CENTER DELIVERY CHARGE:** REMCO offers an appointment/delivery charge to specific distribution centers. Waiting charges apply.

- **DC Delivery Appointment** **\$53.25**

This charge only applies to the following DC's, all other DC's will be subject to standard accessorial:

- Costco Vaughan, Varennes
- HBC
- Walmart Mississauga
- Red Apple

- **AMAZON DISTRIBUTION CENTER DELIVERY CHARGE:** Due to the time of delivery appointments and detention time incurred while making Amazon deliveries, the following rate applies to all Amazon DC deliveries: **\$159.50/shipment**

- **NOTE: Additional fees may apply including detention, after hours, and appointment charges**

**25. RESIDENTIAL / INSIDE PICK-UP AND/OR DELIVERY**

Shipments will be billed **\$79.75** in the following circumstances:

- a. Any shipment picked up or delivered to a private residence.
- b. Any shipment picked up or delivered beyond 5' inside the back door.
- c. Any shipment picked up or delivered further than 5' inside the front door.
- d. Retail malls defined as any malls where unloading dock is shared by multiple stores. Malls such as power centers not included.

**26. CONSTRUCTION SITE PICK-UP AND/OR DELIVERY**

**\$60.00 surcharge** will apply to shipments delivering to/ picking up at a construction site.

**27. SAME DAY SERVICE (service level: SAMD)**

REMCO offers same day pickup and delivery service:

Minimum charge of: **\$315.50**  
 If shipments exceed 3 hours, charges of: **\$315.50** plus applicable **\$105.25** per hour will apply.

- a. This service covers any shipment picked up and delivered on the same day.

**28. SHIPMENT IDENTIFICATION**

All shipments must be clearly identified. Any shipment not clearly identified will be re-labeled by Remco and a **\$5.75** charge for every unit of the shipment (shipment unit of measure, cartons, sets, pallets, etc.) will be applied.

**29. SPOT QUOTE SURCHARGE**

- a. Spot quote surcharge - **\$26.50**

**30. STORAGE (billed per calendar week / day or part thereof)**

**31. TAILGATE SERVICE**

**\$58.50 surcharge** will apply for either pick-up and/or delivery requiring the use of a tailgate lift.

This charge will be applied for all pick-up and/or deliveries moving within the REMCO direct service points as outlined in the Points and Service Guide.

Maximum skid weight is 2000lbs.

**32. Trailer Detention – (DEMURRAGE)**

Surcharges apply when a trailer is detained by the consignor or consignee beyond the agreed loading / unloading schedule.

- a. **\$80.00/day** or part thereof.

**33. WAITING TIME**

Waiting time on pickup or delivery with minimum billing of \$5.00 and at one (1) minute increments of \$1.50 per minute, for shipments that exceed the allowable time below:

▪ 1 – 999 lbs.:	15 minutes
▪ 1,000 – 4,999 lbs.	30 minutes
▪ 5,000 – 9,999 lbs.	45 minutes

**WAITING TIME GOH (GARMENTS ON HANGERS):** Allowable delivery time for GOH shipments will be 15 minutes per 25 sets with a minimum of 30 minutes and maximum of 120 minutes. For shipments in excess of 200 sets please call for a spot quote.
